- ➤ I will demand a drug, alcohol and tobacco-free sports environment for my child and agree to assist by refraining from their use at all youth sports events.
- ➤ I will remember that the game is for children and not for adults.

- ➤ I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed or ability.
